PARTICIPANTS RANGING FROM AGE 8 THROUGH 17 PARTICIPATED IN A MIX OF PHYSICALLY EXERTIVE ACTIVITIES AND QUIETER PURSUITS. THEY CONFERRED WITH CLINICAL STAFF REGARDING DIABETES MANAGEMENT AT LEAST 4 TIMES DAILY. THEY SPENT TIME WITH OTHERS WHO ARE JUST LIKE THEM IN LEARNING ABOUT AND COPING WITH DIABETES, AND WERE UNDER THE SUPERVISION OF MENTORS. EACH SESSION, OVER 10,000 BLOOD SUGARS WERE CHECKED, OVER 400 PUMP SITES WERE CHANGED AND OVER 190,000 CARBOHYDRATES WERE COUNTED. 38% OF SUMMER CAMPERS RECEIVED SCHOLARSHIPS. 367 NEW DIABETES SELF-MANAGEMENT SKILLS WERE DOCUMENTED INCLUDING THE ABILITY TO CHECK A BLOOD SUGAR, DRAW UP INSULIN AND CALCULATE INSULIN DOSE TO COVER

FAMILIES HAD THE CHANCE TO CONNECT AND DEVELOP FRIENDSHIPS THAT CAN SUSTAIN THEM LONG AFTER THE WEEKEND ENDS. CAMP KUDZU SERVED 71 FAMILIES, AND 37% RECEIVED
